

Extraordinary General Meeting Minutes

7:00pm, Thursday April 8, 2021 Conducted online via Zoom (due to COVID-19 health restrictions)

Board members in attendance: Madeline Boscoe, Marie Jones

Total number of voting members present: 71

Member attendees were admitted from the Zoom waiting room to the meeting at 7:00pm.

Madeline welcomed everyone to the meeting and introduced Janni Kretlow, who will facilitate the logistics of a Zoom meeting including voting.

As the President position was vacant, Madeline Boscoe, Vice President called the meeting to order at 7:17pm . There was a question from the floor regarding quorum. The member was informed there was a quorum as NSCGS bylaws state 15 people constitute a quorum.
